 - The specific role of YouthDESC should be featured

- The role of Indigenous DESC was discussed, since it could be seen as being a similar cross-cutting theme to Youth, but it was agreed that for the moment it should remain as a normal TWG. It was emphasised that TWGs need space to forge their own identities, but should not be reductionist; membership of TWGs is open to all Members and Associate Members, who should be encouraged to contribute across several different TWGs.
- Greater clarity should be provided on the different sorts of TWG (thematic, tech-related, environment-related etc.)
- Should include greater clarity on how TWGs can be initiated, emphasising that they are intended to be bottom-up and flexible, originating through the suggestions of members. Where a proposed TWG seems to be closely similar to an existing one, those recommending it should be encouraged to think of participating in the existing one.
- Could refer to benefits of membership of TWGs.
